

# Wyse Technology End User License Agreement For Use With The Linux Software (“License”)

---

## IMPORTANT – READ CAREFULLY:

**THIS LICENSE IS A LEGAL DOCUMENT setting forth the terms under which Wyse Technology Inc. (“Licensor”) and its licensors and suppliers (collectively referred to as “Third Party Suppliers”) are willing to license to you software which is owned by Licensor and/or its Third Party Suppliers, who are intended third party beneficiaries under this License. You are being provided with either the enclosed software, downloaded software, or software described in the manual or other document containing this License, whichever is applicable (“Software”) together with any supplied documentation.**

**Linux Software.** The operating system (“OS”) provided with the Software under this License is called the “Wyse-Linux-V6”. The Wyse-Linux-V6 consists of individual software components that were developed by individuals and entities other than Wyse, and certain additions and modifications thereto developed by Wyse (“Linux Software”). Portions of the Wyse-Linux-V6 are distributed under the terms of the GNU General Public License (“GPL”) and other similar license agreements that permit you to copy, modify and redistribute the Linux Software, and that require that any copy of such Linux Software distributed to you by Wyse be distributed on the terms of such License (each a “Free Software License”). **Acceptance.** Licensor is willing to license to you the Software together with any supplied documentation, only if you accept all of the terms contained in this License. Please read this Agreement carefully before unpacking, downloading, copying or using the Software. By doing any of the above, you agree to be bound by the terms of this License. If you do not agree to these terms, Licensor and its Third Party Suppliers are unwilling to license the Software to you, and you should not and may not unpack, download, copy or use the Software.
